There are 63.17 CRP acres enrolled into the CP1 program paying \$173.36 per acre or an annual payment of \$10,951 expiring in 2024. Total potential tillable acres is 99.49 with a CSR2 value of 48.5.

With water and electric at the road and the farm's proximity to the highway, this would be a great location to build your dream home. Additionally, the pasture acres and 40' x 60' pole building offer a great opportunity to run livestock. There are a number of options available to the new owner of this farm.




