KNOWN ALL MEN BY THESE PRESENTS:




A part of the Northeast Quarter of the Northwest Quarter of Section 14, Township 17 North, Range 4 West, being more particularly described as follows:

Beginning at the Southeast corner of the Northeast Quarter of the Northwest Quarter of Section 14, Township 17 North, Range 4 West, thence North along the East line of said NE $\frac{1}{4}$ NW $\frac{1}{4}$ to the South side of the County Road; thence West along the South side of the County Road 25 feet; thence South to the South line of said NE $\frac{1}{4}$ NW $\frac{1}{4}$; thence East 25 feet to the point of beginning.

To have and to hold the same unto the said Grantees, and unto their assigns and successors forever, with all appurtenances thereunto belonging.
