

The Northwest Quarter of the Northwest Quarter (NW¹/₄NW¹/₄) of Section Three (3); and

The North One-half (N¹/₂) of Section Four (4) EXCEPT Parcel "A" being a part of the Northwest Quarter of the Northwest Quarter (NW¹/₄NW¹/₄) and part of the Northeast Quarter of the Northwest Quarter (NE¹/₄NW¹/₄) of Section Four (4), Township Seventy-two (72) North, Range Twenty-six (26) West of the 5th P.M., Clarke County, Iowa, as shown in the Plat of Survey recorded June 6, 2007, in Book 44 at Page 151 in the Office of the Recorder of said County, described as follows: Beginning at the Northeast corner of said Northwest Quarter of the Northwest Quarter (NW¹/₄NW¹/₄); thence N86°56'26"E a distance of 100.14 feet; thence S00°00'00"E a distance of 280.40 feet; thence S86°56'26"W a distance of 405.58 feet; thence N00°00'00"E a distance of 280.40 feet; thence N86°56'26"E a distance of 305.44 feet; to the point of beginning, having an area of 2.61 acres including acres of county road right of way easement; and

The Southwest Quarter (SW¹/₄) of Section Four (4), and the South One-half of the Southeast Quarter (S¹/₂SE¹/₄) of Section Five (5), EXCEPT Parcel D - a part of the Southwest Quarter of the Southwest Quarter (SW¹/₄SW¹/₄) of Section Four (4) and part of the Southeast Quarter of the Southeast Quarter (SE¹/₄SE¹/₄) of Section Five (5), described as follows: Beginning at the Southwest corner of said Southwest Quarter of the Southwest Quarter (SW¹/₄SW¹/₄); thence S88°17'13"W a distance of 22.36 feet; thence N01°07'05"W a distance of 148.26 feet; thence N88°23'10"E a distance of 21.97 feet; thence N01°02'42"W a distance of 55.97 feet; thence S88°43'18"W a distance of 24.12 feet; thence N01°24'09"W a distance of 137.20 feet; thence N88°36'46"E a distance of 225.60 feet; thence S03°37'34"E a distance of 138.51 feet; thence N87°54'24"E a distance of 15.76 feet; thence S01°58'56"E a distance of 199.19 feet; thence S87°35'02"W a distance of 225.36 feet; to the point of beginning, having an area of 1.834 acres including 0.229 acres of county road right of way; and

All that part of the Southeast Quarter of the Northwest Quarter (SE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Five (5) lying East of the County Road, and the Northeast Quarter (NE $\frac{1}{4}$) of Section (5) EXCEPT a parcel described as commencing at the North Quarter Corner, thence South 922.0 feet to the point of beginning, thence East 200 feet, thence South 262 feet, thence West 200 feet, thence North 262 to the point of beginning, AND EXCEPT that part of Lot Two (2) of the Replat of Parcel "A" - Being a part of the Northeast Quarter (NE $\frac{1}{4}$), part of the Southeast Quarter (SE $\frac{1}{4}$), and part of the Northwest Quarter (NW $\frac{1}{4}$) of Section Five (5), Township Seventy-two (72) North, Range Twenty-six (26) West of the 5th P.M., Clarke County, Iowa, as shown in the Plat of Survey recorded September 4, 2001, in Book 43 at Page 609 in the Office of the Recorder of said County, that lies therein; all being in Township Seventy-two (72) North, Range Twenty-six (26) West of the 5th P.M., Clarke County, Iowa.

and

The Southwest Quarter of the Northwest Quarter and the North Half of the Southwest Quarter of Section 3, Township 72 North, Range 26 West of the 5th P.M., Clarke County, Iowa.
