Peoples Company is pleased to be representing Hansen Bauernhofe LLC in the sale of their Crawford County farm located just north of Aspinwall, Iowa and west of Manning, Iowa. The property consists of 92.67 acres m/1 and is situated in Section 15 of Iowa Township, Crawford County, Iowa.

Offered as one tract, the farm includes 86.42 FSA cropland acres and a CSR2 soil rating of 71.2. Prominent soil types include Zook silt loam, Exira silty clay loam, and Judson silty clay loam. Of the cropland acres, 27.26 acres are considered Non-Highly Erodible Land (NHEL) and the remaining 59.16 are considered to be Highly Erodible Land (HEL). The balance of the tract consists of an open ditch running through the property. Access is from both U Avenue and 380th Street, and the farm sits just half a mile off Iowa Highway 141, offering quick access to the Iowa Highway system.

Grain marketing options are located nearby with the Aspinwall Cooperative Co., just south of the property in Aspinwall, Iowa, and Ag Processing Inc., a few miles east in Manning, Iowa. The farm lease has been terminated, and farming rights are available for the 2026 growing season. Don't miss this opportunity to own land in a tightly held area where land rarely makes it to the open market!

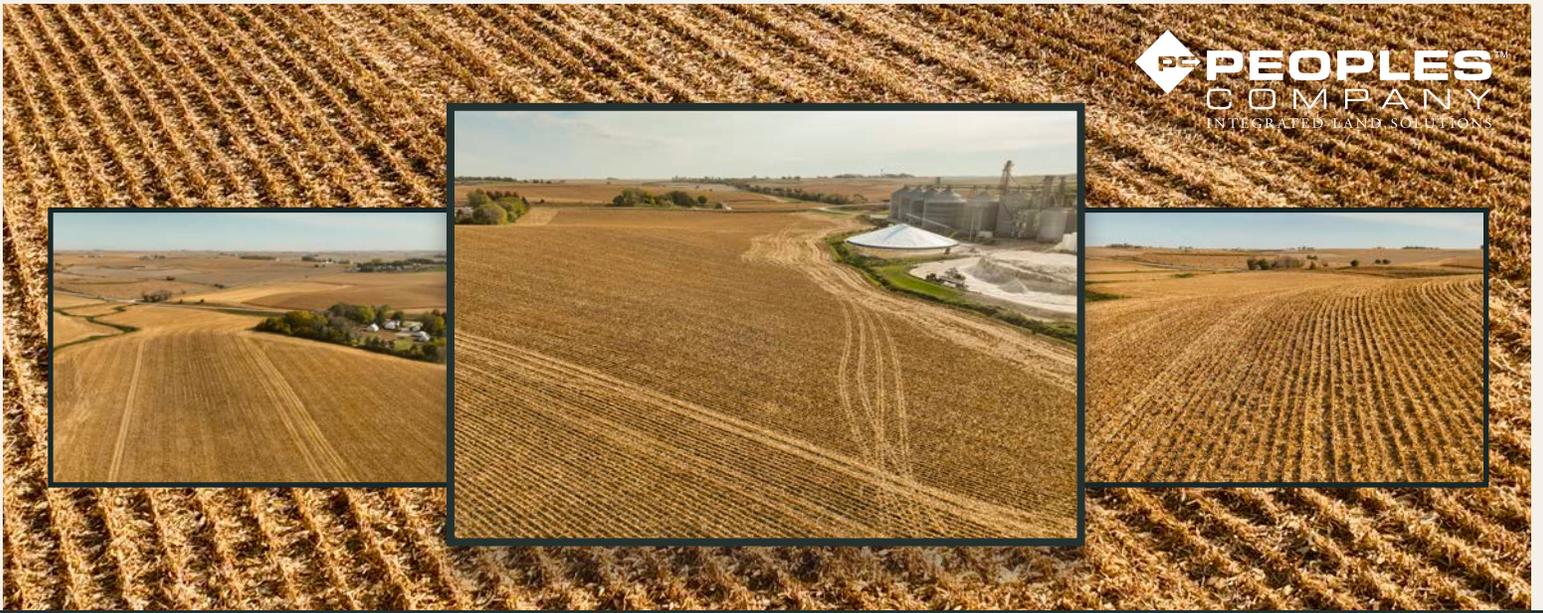

Auction Method: The farmland will be sold as one individual tract on a price-per-acre basis to the High Bidder.

Winning bidder(s) acknowledge they are representing themselves in completing the auction sales transaction.

Agency: Peoples Company and its representatives are agents of the Seller. Winning Bidder(s) acknowledge they are representing themselves in completing the auction sales transaction.

Farm Program Information: Farm Program Information is provided by the Crawford County Farm Service Agency. The figures stated in the marketing material are the best estimates of the Seller and Peoples Company; however, Farm Program Information, base acres, total crop acres, conservation plan, etc., are subject to change when the farm is reconstituted by the Crawford County FSA and NRCS offices.

Earnest Money Payment: A 10% earnest money payment is required on the day of the auction. The earnest money payment may be paid in the form of a check or wire transfer. All funds will be held in Peoples Company's Trust Account.

Closing: Closing will occur on or before Tuesday, January 20th, 2026. The balance of the purchase price will be payable at closing in the form of cash, guaranteed checks, or wire transfers.

Possession: Possession of the land will be given At Closing, Subject to the Tenant's Rights.

Farm Lease: The farm lease has been terminated, and farming rights are open for the 2026 growing season.

Contract & Title: Immediately upon the conclusion of the auction, the high bidder will enter into a real estate sales contract and deposit the required earnest money payment into the Peoples Company Trust Account. The Seller will provide a current abstract at their expense. The sale is not contingent upon Buyer financing.

Financing: The purchaser's obligation to purchase the Property is unconditional and is not contingent upon the Purchaser obtaining financing. Any financial arrangements are to have been made before bidding at the auction.
