

Peoples Company is pleased to offer this 120 M/L acre combination farm featuring highly productive row-crop ground, pasture, hunting land, and potential building sites, located just southwest of Moulton and east of Centerville in Appanoose County, lowa. The property lies in Sections 21 and 28 of Wells Township on 560th Street, just over a mile west of Highway 202.

This versatile farm presents a variety of opportunities for the next owner. The balance of the property is currently in grass pasture, timbered draws and a pond.




