TRACT 1 - 63.80 ACRES M/L



Tract 1 consists of 63.80 acres m/l located southwest of Grand Junction, Iowa. The farm includes 62.12 FSA NHEL cropland acres and a CSR2 soil rating of 78.7. Prominent soil types include Canisteo clay loam and Nicollet loam with over 65% of the farm carrying a CSR2 soil rating of 83 or higher.

Private and county drainage tile is located on the tract. A private 6" tile line lies on the north half of the farm and connects to a 6" county tile line at the property boundary, draining water east off the farm. Three drainage intakes are located on the farm, suggesting additional private tile has been installed. Drainage District #122 borders the farm to the east, and water eventually outlets into an open ditch in the section just north of the tract.

The farm is leased for the 2026 growing season and the Buyer(s) will receive the 2026 rental income, with payments due in the spring after closing and on September 1, 2026. Yield history is available upon request, contact the listing agent for more information.

Tract sizes range from 63.80 acres to 156.20 acres and would make for great add-on tracts to an existing farming operation or an investment for the Buyer looking to diversify their portfolio or hedge inflation.

- Tract 1:** 63.80 acres m/l with 62.12 FSA cropland acres and a CSR2 soil rating of 78.7

These tracts are located in a strong farming community with several grain marketing options located nearby, including the Louis Dreyfus ethanol plant located within four miles of each tract. The farms are leased for the 2026 growing season and the Buyer(s) will receive the 2026 rent payments. The payments will be made this spring after closing and on September 1, 2026. The farms lie on or near paved roads, offering quick access to the Iowa Highway system and nearby grain marketing outlets.

TRACT 2 - 156.20 ACRES M/L



Tract 2 consists of 156.20 acres m/l located northwest of Grand Junction, Iowa. The farm includes approximately 149.55 FSA NHFL cropland acres and a CSR2 soil rating of 61. Iowa Highway 144 runs along the eastern border of the tract, offering easy access to local grain markets. The tract sits just across the road from the Louis Dreyfus ethanol plant.

An open drainage ditch associated with Drainage District 169 cuts through the eastern half of the tract, with water flowing south off the farm. There are three drainage tile intakes located on the tract, suggesting drainage tile is present. Two Sukup grain bins built in 2012 are on the tract and each hold 15,000+ bushels. The west bin has a dryer and stirator system that will be included. There is a liquid propane tank on the bin site that will not transfer with the property and will be removed in the spring. Additionally, a 25 foot access easement will be given by the adjoining acreage owner along the east side of the drainage ditch.

The farm is leased for the 2026 growing season and the Buyer(s) will receive all of the 2026 farmland and grain bin rental income, with payments due in the spring after closing and on September 1, 2026. Yield history is available upon request, contact the listing agent for more information.

DIRECTIONS

Tract 1: From Grand Junction, Iowa: Head south out of town on Iowa Highway 144 for half a mile. Then, turn right (west) onto County Highway E53 / 230th Street and go for 2 miles. The farm will be on the left (south) side of the road.

Tract 2: From Grand Junction, Iowa: Head north out of town on Iowa Highway 144 for approximately 2 miles. The farm will be on the left (west) side of the road.

Tract 3: From Grand Junction, Iowa: Head north out of town on Iowa Highway 144 for approximately 2 miles. Then, turn left (west) onto 200th Street and go for 1 mile. Next, turn right (north) onto T Avenue and go for half a mile. The farm will be on the right (east) side of the road.



TRACT 3 - 80 ACRES M/L



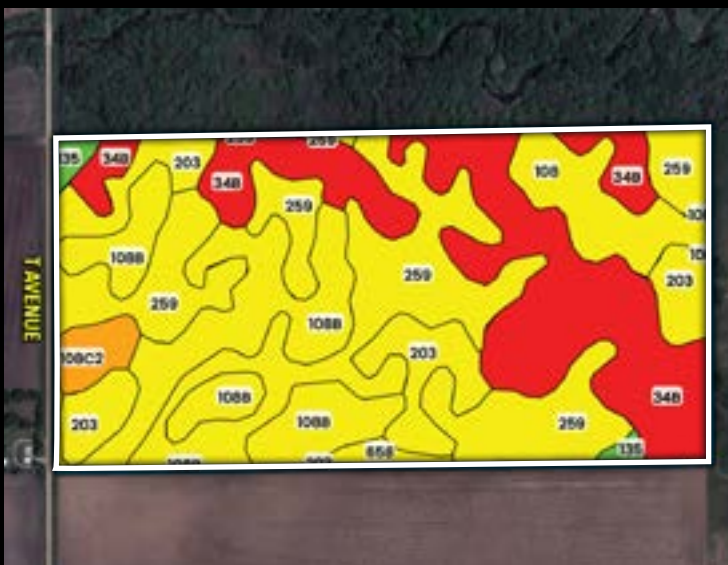
Tract 3 consists of 80 acres m/l with 79.35 FSA cropland acres that are currently enrolled in the Conservation Reserve Program (CRP) under the State Acres for Wildlife Enhancement (SAFE) initiative, focusing on Rare and Declining Habitat and Iowa Prairie Restoration for grassland songbirds.

CRP Contract Details:

Contract #11983 - 79.35 Acres enrolled in the SAFE - Iowa Gaining Ground (CP38E-25) with an annual payment of \$18,340 (\$231.13/Acre). This contract is set to expire in September 2032.

*Note on the CRP Contract: The Beneficiaries have not made a decision on the CRP contracts, and the successful bidder would have the optionality to either continue the CRP contract or choose to discontinue the farm's enrollment in CRP. Upon signing of the Purchase Agreement, the winning bidder will let the family know how they would like to proceed with the CRP contracts.

The East Burrick Creek flows just north of the property and provides a water source to local wildlife, bringing recreational opportunities to the tract.
