The farm's diverse landscape provides ample opportunities for recreation, including two existing ponds and space and topography for a potential large pond, making it ideal for deer & turkey habitat, or waterfowl attraction.

Less than 10 minutes from Van Meter and only 20 minutes from West Des Moines, this property combines rural tranquility with urban convenience. The outstanding Van Meter School District and close proximity to the Des Moines Metro enhance its appeal as a prime building site. The farm's elevated hilltop offers stunning views of the Madison County countryside, while the surrounding timber and tree lines provide privacy from the road.

There's ample room to expand the existing pasture, create more tillable acres, hold livestock, plant a hobby farm, build a riding arena, or add a pole barn. The farm's location also makes it an excellent candidate for future development just across the street from Badger Creek State Park. A newly installed driveway allows convenient access from Badger Creek Road. Rural water and MidAmerican Energy electricity are available at the road, with additional acres potentially available. Then, in 1.1 miles, turn right onto Tabor Road and continue south for 1.1 miles. Continue onto Badger Creek Road, and in 2.6 miles, the farm will be on the left/to the east.
