

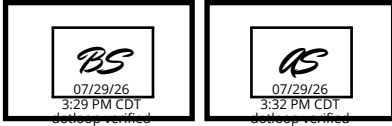
Disclosure of Information on Lead-Based Paint and/or Lead-Based Paint Hazards
