APPLICATION FOR CONDEMNATION AND APPOINTMENT OF COMMISSIONERS

TO: THE HONORABLE PHILLIP R. COLLETT, CHIEF JUDGE, EIGHTH JUDICIAL DISTRICT OF IOWA.

COMES NOW the City of Ottumwa, Iowa a municipal corporation located in Wapello County, Iowa, by and through its attorney of record, Thomas F.
