

Parcel D, Parcel E and Parcel F in the NE 1/4 of Section 18 - T94N - R16W, Floyd County, Iowa.

Legal Description:

Parcel D in the Northeast Quarter of Section 18, Township 94 North, Range 16 West of the 5th P.M., Floyd County, Iowa, and more particularly described as follows:

Beginning at the North Quarter Corner of said Section;

Thence **North 89°24'19" East, 907.00 feet** along the North Line of said Quarter Section to the Northwest Corner Parcel C, as recorded in Document #2013-0745, on file in the Floyd County Recorder's Office, Charles City, Iowa;

Thence South 01°52'56" East, 282.00 feet;

Thence South 64°32'41" East, 157.00 feet;

Thence North 89°24'19" East, 80.00 feet;

Thence North 56°35'34" East, 173.25 feet;

Thence **North 00°35'41" West, 257.00 feet** all along said Parcel C to the Northeast Corner thereof and said North Line;

Thence **North 89°24'19" East, 409.60 feet** along said North Line to the Northeasterly Extension of the Centerline of an existing Drainage Ditch;

Thence South 39°59'17" West, 658.6 feet more or less;

Thence South 11°43'45" West, 88.4 feet more or less;

Thence South 01°54'45" East, 414.2 feet more or less;

Thence **South 05°07'17" East, 775.2 feet more or less** all along the Centerline of said Drainage Ditch and Northeasterly Extension thereof to the Confluence of the Centerline of Flood Creek and the East Line of the West Half of the Northeast Quarter of said Section;

Thence South 89°48'09" West, 198.5 feet more or less;

Thence North 57°52'07" West, 257.2 feet more or less;

Thence North 76°07'47" West, 556.4 feet more or less;

Thence North 32°34'11" West, 427.3 feet more or less;

Thence North 09°40'15" West, 170.1 feet more or less;

Thence **North 41°28'22" West, 169.0 feet more or less**, all along the Centerline of Flood Creek to the West Line of said Quarter-Quarter Section;

Thence North 00°17'39" West, 835.79 feet more of less along said West Line to the Point of Beginning.

Containing **43.45 Acre(s) more or less**, including 1.32 Acre(s) of County Road B60 (270th Street) Right-of-Way, subject to any easements recorded or unrecorded.
