DESCRIPTION

COMMENCING AT THE SOUTHWEST CORNER OF THE SOUTHEAST QUARTER OF SECTION 32, TOWNSHIP 36 NORTH, RANGE 13 WEST, PULASKI COUNTY MISSOURI, THENCE ALONG THE SOUTH LINE OF SAID SECTION 32 S88°58'00"E 13.31 FEET TO THE EAST RIGHT OF WAY OF RANGE LANE AND THE POINT OF BEGINNING, THENCE ALONG SAID RIGHT OF WAY N01°14'30"E 153.10 FEET; THENCE S88°58'00"E 2845.10 FEET; THENCE S01°25'20"W 153.34 FEET TO THE SOUTH LINE OF SECTION 33 OF SAID TOWNSHIP 36 NORTH, RANGE 13 WEST, THENCE ALONG SAID SOUTH LINE N89°15'30"W 62.58 FEET; TO THE NORTHEAST CORNER OF SECTION 5, TOWNSHIP 35 NORTH, RANGE 13 WEST, THENCE CONTINUING ALONG THE SOUTH LINE OF SECTION 33 N88°44'00"W 139.20 FEET TO THE SOUTHEAST CORNER OF SECTION 32, TOWNSHIP 36 NORTH, RANGE 13 WEST, THENCE ALONG THE SOUTH LINE OF SAID SECTION 32 N88°58'00"W 2642.84 FEET TO THE POINT OF BEGINNING. 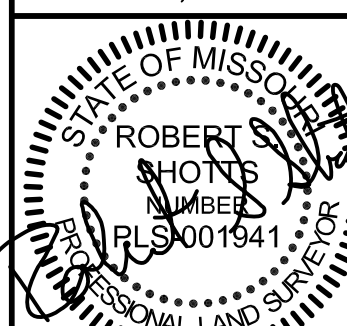
