Further, the Grantors hereby agree that the lump sum payment as shown on the referenced purchase agreement is payment in full for any and all damages arising from

Fremont County Project No. NHSN-059-1(33)--2R-36 Joyce E. McLaren, et al (Parcel No. 1) the increased flow and drainage of water due to said project.

This easement, and a certain Easement for Public Highway to the State of Iowa, executed by the above named grantors are given in fulfillment of a certain Purchase Agreement dated Spicial 1, 20 22, and recorded in the Fremont County Recorder's Office on Spicial 1, 20 22, at Book 2022, Page 326, as Document No. 2021326, except for those terms that survive the execution of this document.

The additional amount of \$\(\frac{146,450.00}{} \), as agreed to by the aforesaid Agreement, is paid as severance damages to the remaining property and is not subject to real estate transfer tax.

Grantors do hereby covenant with grantees, and successors in interest, that grantors hold the real estate by title in fee simple; that they have good and lawful authority to grant an easement on the real estate; and grantors covenant to warrant and defend the real estate against the lawful claims of all persons except as may be above stated. Each of the undersigned hereby relinquishes all rights of dower, homestead and distributive share in and to the easement.

The terms of this agreement shall be deemed to run with the land and be binding upon grantors successors.
